PAYMENT AUTHORIZATION

Dallas Athletes Endurance Sports, Inc. (DAES) requires a secure method for payment of membership dues using a credit or debit card. Membership dues will be charged 30-days in advance, on the 10th of each month. The undersigned hereby authorizes DAES to automatically charge the designated credit/debit card, on a monthly basis, any and all amounts due and owing to DAES for membership. MEMBERSHIP

TERMINATION OF MEMBERSHIP

A member may resign from DAES for any reason by giving a thirty-day written notice to DAES. To cancel this agreement, the undersigned must notify by certified mail with a return receipt requested or deliver a signed and dated notice to Dallas Athletes Endurance Sports, Inc. 3504 Beckworth Dr. Flower Mound, TX 75022 stating that the undersigned is canceling this agreement. Such voluntary resignation shall not be deemed effective until after the expiration of the thirty-day notice period AND all required payments has been made by the undersigned to DAES. Subsequent to his or her voluntary resignation, the undersigned shall not be subject to any further dues or other charges. Dallas Athletes Endurance Sports also has the right to terminate any membership at any time if a member engages in activities that reflect poorly on the membership or is in direct competition with any portion of Dallas Athletes Endurance Sports including all events, training and membership related activities. If membership is terminated, refunds will not be given.

ASSUMPTION OF RISK, RELEASE AND INDEMNITY

The participation in all activities of DAES involves the risk of injury or death. As such, the undersigned agrees that he or she understands and voluntarily accepts this risk and agrees that DAES will not be liable for any injury, including and without limitation, personal, bodily or mental injury, economic loss or any damage to the undersigned, the undersigned's spouse, guest, or from the negligence or other acts of DAES or anyone else participating in DAES's activities. If there is any claim by anyone based on any injury, loss or damage described herein, which involves the undersigned, any member under this agreement, any or the undersigned's non-member children or any guest or child which the undersigned or any member under this agreement has brought to DAES, the undersigned agrees (a) defend DAES against such claims and pay DAES for all expenses relating to the claim, and (b) indemnify DAES for all obligations resulting from such claims.

WAIVER OF LIABILITY

In consideration of the acceptance of club membership, the undersigned, intending to be legally bound for his or her self, his or her heirs, executors, administrators, and assignees, waive, release, and forever discharge DAES and its officers and members, and any sponsor of DAES, for all rights and claims of damages, demands, actions, whatsoever in any manner arising growing out of the undersigned's participation in all activities of Dallas Athletes Endurance Sports, Inc.
